She is a member of the State Bar of Texas and the Lubbock Area Bar Association, Life Fellow of the Texas Bar Foundation, a board member of the Texas Bar College, and an honorary lifetime member of the West Texas Justices of the Peace & Constables Association. She also a course director for **Continuing Legal Education** 'Advanced Civil Trials', and summer school for the State Bar of Texas. Additionally, she is a board member of the **Community Foundation of West Texas** and the **YWCA** and was a former board member for the **Ronald McDonald House** and **Meals on Wheels**.
